INTRODUCTION

Due to the timing of the 2020 Census, as well as the projected update of the County Comprehensive Plan, Parks & Recreation staff along with the Recreation Advisory Commissions are recommending that the Board of Supervisors amend the current Parks and Recreation Master Plan. Parks and Recreation staff and the Recreation Advisory Commission will begin the next Parks and Recreation Master Plan update in lockset with the Comprehensive Plan update.

The amended Goochland County 2016-2020 Parks and Recreation Master Plan is Goochland's most recent effort to strategically plan for future parks and recreation facilities and services. The master plan is necessary to evaluate citizen demand for services versus current services provided, to guide planning for future facilities, and to support cost effective allocations of valuable County resources.

The plan consists of several sections. The sections in the amended 2016-2020 Master Plan will; describe current service levels as it pertains to current facilities and programs, identify state and national level of service standards, summarize the data collection and analysis methodology to support the plan's recommendations, summarize the plan's recommendations, and provide a discussion on budget/funding implications for the recommendations.

The amended Master Plan aims to guide parks and recreation decision making in the County for the next five years and further intends to be the foundation for future funding and policy decisions. Ideally, the Master Plan will augment other County planning efforts including the County's comprehensive plan. Importantly, the Plan seeks to complement and not to supersede the mission of any public agencies or other policy documents or plans.



The purpose of the Goochland County Parks and Recreation Master Plan is to help identify and meet the facility and programming needs of current and future residents of Goochland County. This plan is intended to provide clear cut direction to County staff, the Recreation Advisory Commission, and elected officials in their efforts to provide and enhance current and future leisure and recreation services.

Goochland Parks and Recreation Facility Overview:

Goochland County Parks and Recreation currently maintains 8 parks/outdoor recreation areas covering 426 acres including 15 athletic fields, James River access, outdoor performance areas, 3 playgrounds, and approximately 12 miles of walking trails. The Department also maintains three indoor recreation facilities including recreation classrooms, 2 full sized gymnasiums, weight room, cardio room, a dance studio, theater, and senior's lounge.

Goochland Parks and Recreation mission statement:

To enhance the quality of life of all Goochland citizens by providing, developing, and advocating for quality parks and recreational resources and leisure services.

Project Methodology

The Parks and Recreation Master plan process began in May 2014 and ran through November of 2015 and has been guided by the Recreation Advisory Commission and Recreation Team staff. The project has consisted of the following efforts:

- a. Public Input surveys, public meetings
- b. Current Park and Programming Inventory
- c. Levels of Service Analysis both national and state level
- d. Trends Analysis locally and state wide
- e. Recommendations & Proposals area and facility development/improvement and program/service development



Demographics and Population Trends

Data was collected through the use of a simple random survey as well as through public meetings with the Recreation Advisory Commission. The survey was distributed utilizing county email, social media, handouts at special events and programs, and through mailings. The data collected included 568 responses. The data told us the following;

- 1. Based upon our sample size in relation to our estimated population, we have a confidence level of 95% with a confidence interval of 4%. SO WHAT DOES THIS MEAN? Most survey studies shoot for these levels and intervals on average. We are 95% confident in our answers and our margin of error is 4%. In other words, we have good, solid, representative data here.
- 2. The highest responding zip code was 23103, followed by 23063 and 23238. As one looks at the response rate by zip code, the statistical breakdown mirrors population estimates, further legitimizing how data was collected and its representation of the population.
- 3. Most respondents are between the ages of 35-46, are overwhelmingly employed, and make over \$71,000 per year as a household. Many respondents are empty nesters followed by homes with 1-4 children. The majority of homes with children in them have children between the ages of 9-12. Ages 6-8 are the second largest grouping, followed by 13-15.

- 4. True statement: Parks and Playgrounds in Goochland County are enjoyable to visit. Parks and open spaces should be important considerations on future land use decisions. A community's quality of life is enhanced through a well developed park system.
- 5. Park Visitation: Folks who are aware of and visit the parks are satisfied with all recreational locations except for the Central High School site. Awareness of facilities does seem to be an issue but this could be tied to the fact that several locations are new, naming may be an issue, and that most of the folks live a great distance from the sites. Most respondents use P & R amenities sometimes and on a regular basis.
- 6. Park Development: The following areas were identified in rank order for development.
 - 1. Eastern Goochland
 - 2. Central Goochland
 - 3. Western Goochland.

Responses on this topic mirrored location origination of responses. Most folks are willing to drive 10-14 minutes to participate in activities/parks.

- 7. Amenities of Park Development: Highest Desire: Trails, Playgrounds, Picnic Areas, Multipurpose Fields, Senior Center. Lowest Desire: Field Hockey and Lacrosse Fields
- 8. Awareness: Folks receive information about their services by word of mouth, newspaper, Internet, and other publications.
- 9. Activities/Programs: Most highly desired programs and activities that aren't currently offered: Cultural arts, indoor exercise, educational enrichment, bicycling, boating/canoeing/fishing, outdoor concerts, public river access

Qualitative Data: Over 200 responses were given to our open ended questions. Reoccurring responses and feedback were as follows:

- Outdoor concerts are desired.
- 2. James River boating access is highly desired.
- 3. People tend to want access to self directed activities (indicative of busy lifestyles): walking/jogging trails, horseback riding, playgrounds.
- 4. Citizens would use parks if they were located in their areas.
- 5. Requesting alternatives to the YMCA after school program.

Recommendations

Recommendations on facility enhancement/ development and programming strategies focused on the following parameters;

Parameters:

- 1. Align with Board of Supervisor's Strategic Plan.
- 2. Facility development would meet the desires/needs of the citizens.
- 3. Facility development would address deficits in levels of service standards.
- 4. Complete existing projects as a priority.
- 5. Improve high volume use areas.

Align with Board of Supervisor's Strategic Plan – all facilities and programming would be designed and implemented in a way as not to add significant impacts to the operating budget of Goochland County while positively contributing to the quality of life of Goochland citizens.

Facility Development – recommendations made on facility development would look for an intersection of two main lines. The first line would be the desires and needs of the citizens identified through the data collection methodology. The second line would flow from the identified level of service standards and deficits identified for Goochland County. The intersection of lines would be the focal point for facility and programming recommendations.

Existing Projects – Existing projects are awaiting completion. Tucker Park Pedestrian Bridge and Central

High Artisan Center are in the middle of improvements and development. The Plan looks to finish those endeavors as a priority.

High Volume Areas – The Plan identifies high volume use areas and endorses the upgrading of those high traffic areas to meet existing and future citizen demand.

Programming Recommendations

Programming efforts of the Department were examined, analyzed, and compared to other service providers in Goochland County. These service providers include other government agencies, local nonprofit organizations, and local businesses.

An attempt was made to identify service providers who already provided programming and Parks and Recreation would seek not to directly duplicate efforts. Some overlap does occur but this is due primarily to citizen demand for certain services. Even at times of overlap, programming differential is attempted and is conscientiously maintained through Recreation staff efforts.

Programming recommendations are also tied to cost recovery, staffing resources, programming locations within the County, and through citizen feedback.

Parks and Recreation Report Card: Master Plan 2010-2015

Goals for the Parks and Recreation Department were a significant focus for the previous

Master Plan. On pages 9 and 10 of the 2010-2015 Master Plan, several goals and objectives were laid out. As part of the process for the 2016-2020 Master Plan, it was important to highlight the performance of the Parks and Recreation Department in terms of meeting those goals.

The following are the results of each goal and objective as well as a brief description.

Objective 8.1

Project and plan for future parks and recreation facilities and programs in advance of public demand.

COMPLETE – SEE BELOW

Objective 8.1.1: The County has the opportunity to undertake long range planning around current and future recreational needs. Maintain a Parks and Recreation Master Plan for the County to address present and future needs and provide a long range vision for parks and recreation.

Strategy 8.1.1a: Research existing facilities and services and develop an inventory of existing supply.

 This effort was initially completed as part of the original Master Plan process from 2010. As part of the 2016-2020 master plan process a new and upgraded inventory was developed and maintained.

Strategy 8.1.1b: Develop a comprehensive needs assessment of future demand based on demographic projections and other factors.

 An ongoing effort by Parks and Recreation to develop a comprehensive programming service matrix with other local service providers coupled with an intense customer survey process has met this strategy.

Strategy 8.1.1c: Maintain a Master Plan detailing existing facilities, future demand, and an implementation strategy to satisfy anticipated demand.

- The efforts of the 2016 - 2020 Master Plan meet this goal.

Strategy 8.1.1d: The County does not currently provide public access to the James River. Develop a park facility on the Tucker property along Rte. 522 to provide this access.

- Tucker Park at Maidens Crossing was opened in the fall of 2012 and allows access to the James River. The park is continuing to see community efforts to develop its resources.
- Since 2015 Tucker Park has seen many additions, including CarMax Cares Stage, boat launch, outdoor classroom, playground, Tucker Bark Dog Park, and an overflow parking lot. Future plans include an Archery Park and disc golf course.

Strategy 8.1.1e: Develop a strategy for acquiring and maintaining public access to the James River.

- Parks and Recreation is currently working with the Community Development Department to identify

and implement methods of obtaining access along the James River in addition to Tucker Park.

Goal 8.2: Parks and Recreation Planning - Provide park and recreation facilities to meet the needs of current County residents and the growing population.

Objective 8.2.1: Manage development and maintenance of new and existing facilities.

Strategy 8.2.1a: The County should create additional park facilities including:

Acquire property affording public access to the James River without a railroad crossing conflict.

- Tucker Park at Maidens Crossing met this strategy.

Establish a new County park which includes soccer, baseball, softball, or football fields. The Bourne property may be an acceptable location.

- Leakes Mill Park (formerly the Bourne property)
 was established and opened in 2013. The park
 currently has two multi-purpose athletic fields, a
 concession stand/restroom facility, and an
 extensive trail system.
- Leakes Mill has since added an additional oversized multipurpose athletic field, two picnic shelters, playgrounds, nine miles of mountain bike trails.

Establish a County park which supports agricultural and equestrian events, shows, activities, etc. The Bourne property may be an acceptable location.

- Nothing at this time.
- The Agricultural Center (opened in 2019) at the Central High Complex has space available to host agricultural events of various types. Statewide trainings have been held using the theater and multiple classrooms. The County plans to host the first Agricultural Fair at Central in 2020.

Create County park/recreation facilities on the former middle school site which may include new soccer, baseball, softball, or football fields.

 Over the past 5 years, staff has worked diligently to improve the athletic playing surfaces at the Central High School site. Upgrades have been made to the walking track and the fields have been put on a more detailed maintenance schedule.

Support the use of available property in the County for temporary recreation uses when they can be converted safely and relatively inexpensively.

- Central High Cultural and Educational Complex opened in 2018 and features multiple programming spaces indoors and outdoors. The track has seen many upgrades, and the multiuse fields host soccer games and practices.

Strategy 8.2.1b: Formalize maintenance agreements with School Board to improve upkeep and expand existing school sites to meet recreational needs.



- A formalized agreement with the school system has not been established. However, Parks and Recreation does maintain school sites as part of its mowing efforts. Additionally, Parks and Recreation has worked with all three elementary school PTA's and supported their efforts to improve outdoor recreational amenities.
- Parks, Recreation and Facilities reorganized into two Departments in 2017. All mowing and

maintenance is handled by General Services.

Strategy 8.2.1c: Continue to review County policies and regulations and revise ordinances as needed to require the dedication of adequate open space, park, and recreation areas.

None at this time.

Strategy 8.2.1d: Encourage developers to include open space, walking trails, bridle trails, tot lots, or other amenities with development applications.

Strategy 8.2.1e: Continue to support private sector, non-profit, or other entities attempting to create or expand recreational opportunities in the County.

 Parks and recreation greatly supports other organizations that provide recreational opportunities. Partnerships in program provision as well as combined efforts on County special events are common.

Objective 8.2.2: Provide and coordinate recreational activities for all County residents.

Strategy 8.2.2a: Develop a recreational policy manual.

 The Parks and Recreation Standard Operating Procedure Manual was developed, endorsed by the Recreation Advisory Commission, and adopted by the Department in 2010.

Strategy 8.2.2b: Continue to organize and staff the

Recreation Advisory Committee (RAC). Complete.

Strategy 8.2.2c: Increase citizen participation through publicizing RAC meetings, public comment periods, and annual public hearings on recreation needs. *Complete.*

- RAC Meetings are held every other month and public participation is encouraged.

Strategy 8.2.2d: Survey County residents to find out desired activities.

 Parks and Recreation continuously surveys program participants throughout each programming season. Surveys range from 3-5 questions to our Parks and Recreation Master Plan survey.

Strategy 8.2.2e: Investigate the need for senior citizen programming. *Complete.*

- Parks and Recreation has surveyed the community repetitively for senior programming needs. The Department has also worked with local organizations to identify and implement senior programming.
- Parks and Recreation developed the Forever Young program in 2018 as well as created a dedicated Senior lounge housed in the Central High Complex.

Strategy 8.2.2f: Continue to encourage the County to maintain a full-time recreation staff sufficient to handle

the parks and recreation needs of County residents. Complete.

- The Recreation Team has three full time members and eight part time members (year round).
- Parks and Recreation is comprised of five full time, twelve year round part time, and multiple seasonal part time staff members.

Goals for the Parks and Recreation Department were a significant focus for the previous Master Plan. As part of the process for amending the 2016-2020 Master Plan, it was important to highlight the performance of the Parks and Recreation Department in terms of meeting those goals.

Programming

- ✓ Continue to evaluate existing offerings through the programming matrix.
- ✓ Offer in house adult sports such as basketball and flag football.
- ✓ Work with additional non-profits to create expanded adult softball program.
- ✓ Continue to cultivate Tucker Park's use and nature/educational based programming.
- ✓ Continue to offer self directed activities ex. Weight/cardio rooms, open gym sports, clubs, and senior activities.
- ✓ Focus on facility use and rentals for community activities.
- ✓ Continue to utilize non Parks and Recreation facilities for programming in Eastern and Western Goochland.

2020-2023 Programming Recommendations

- 1. Continue to grow Senior offerings including trips, workshops, luncheons, and other social opportunities.

- 3. Work with Agricultural Center to offer educational programs.
- 4. Continue to work with local non-profit to offer Theatre performances.

COUNTY CHARACTERISTICS AND DEMOGRAPHICS

Increasing demand for park and recreation facilities is largely a function of the County's population. As the County's population grows, the demand for park and recreation services will be expected to increase also. Therefore, a brief review of the County's historical population trends is helpful. *The following information is taken from the 2035 Comprehensive Plan.

Goochland County is located in central Virginia on the western edge of the Richmond Metropolitan Area and approximately 25 miles southeast of Charlottesville. The County is approximately 289 square miles (184,960 acres) in area and the 2018 population estimate is 23,176. The County has an exurban/rural setting and is just west of the heavily populated suburban Henrico County. Weldon Cooper has projected the 2040 population to be 27,505.

The James River flows along the County's southern border and separates the County from Powhatan, Cumberland, and Chesterfield Counties to the south.

County Characteristics and Demographics

The Tuckahoe Creek generally defines the eastern boundary with Henrico County, and Goochland abuts Louisa and Hanover Counties to the north and Fluvanna County to the west.

Interstate 64 traverses the northern part of the County from east-to-west, and four interstate interchanges are located in the County. U.S. Route 250 passes through the County close to and parallel to the interstate, and State Route 6 runs east-to-west in the southern part of the County. State Route 288, which serves as one segment of the outer circumferential highway/ expressway for the Richmond region, crosses the eastern part of the County. Also, U.S. Route 522 is a north-to-south roadway running through the center of the County.

The County is home to West Creek, a 3,500-acre, campus-style business park which serves as the principal economic driver for the County. Major employers in West Creek include Capital One, CarMax.

the Virginia Farm Bureau, and Performance Food Group. Luck Stone Corporation operates facilities countywide including its corporate headquarters near West Creek.

In producing the 2035 Comprehensive Plan, it is helpful to review the demographic profile of the County's past and present. The 2035 Plan recognizes these trends will influence the County's future and foretell, in part, the growth for which the County is anticipating and planning.

- Between 2000 and 2010, compared to adjoining communities, Goochland had one of the largest percentage increases in population.
- Weldon Cooper projected 2010 population was very close to the actual 2010 population: projected 2010 population was 22,078 (actual population was 361 less).
- Between 2010 and 2018, the highest growth rates in the Region are expected to occurred in Goochland, Hanover, and Henrico.
- Weldon Cooper's 2014 estimated Goochland population is 21,703 – This number is less than the 2010 Census population which reflects the decrease in the Group Quarters population (removal of prisoners at the State Farm)

Where is growth occurring in the County?

 Growth is occurring uniformly across the County and not just in targeted villages or Designated



What does Goochland's population look like?

- Median age has increased three years between 2010-2018 to 48.3, which is significantly higher than adjoining localities, and the state.
- The largest increases in population from 1990-2010 have occurred in the age cohorts 45 and above.
- The County had a loss of population in the age cohorts
 44 and below, particularly with 20-34 year olds.
- Fewer children under the age of 5 are living in the county compared to the US.
- 22% of residents are over the age of 65.
- Household and family income is significantly higher than US average and one of the highest in the region.
- Low poverty rates.
- The labor force in Goochland County is roughly 57%, which is similar to adjoining localities.
- Demographics reflect high number of retirees in the County.
- Travel time to work is higher than national average
- 13% of the County's population lives and works in the County.
- High number of owner occupied units in the County, limited number of rental units.





Projected Population













Economic Characteristics





The County has consistently gained population for decades. While exact growth rates vary annually, the County's recent average annual growth rates in the 2.0-3.0% range are consistent with the County's Comprehensive Plan recommendations. Therefore, population growth will continue to boost the overall demand for public park and recreation facilities and services.

While growth rates may be higher in the eastern portion of the County, population growth continues to occur, to some extent, County-wide. This presents an additional challenge in balancing the location and expenditure of scarce park and recreation resources in an equitable manner. In order for the 2016-2020 Parks and Recreation Master Plan to meet its stated goals, a detailed needs assessment had to take place prior to any recommendations on facility development or programming design and implementation to take place.

The needs assessment was conducted utilizing the Master Plan survey. The survey consisted of both closed and open ended questions aimed at gathering both quantitative and qualitative data. Surveys sought to identify the following; location of respondent, current attitudes and uses towards existing parks and recreation amenities, programming trends, and thoughts on future development.

The Parks and Recreation Master plan process began in May 2014 and proceeded through to its adoption in November of 2015 and has been guided by the Recreation Advisory Commission and Recreation Team staff. The project has consisted of the following efforts:

- a. Public Input surveys, public meetings
- b. Current Park and Programming Inventory
- c. Levels of Service Analysis state level
- d. Trends Analysis locally and state wide
- e. Recommendations & Proposals area and facility development/improvement and program/service development



Needs Assessment

Public Input

Public input for the 2016-2020 Parks and Recreation Master Plan was garnered utilizing multiple methods. The methods utilized included the general survey, public meetings organized by the Recreation Advisory Commission, and through face to face interaction with users of existing facilities.

The general survey was the primary vehicle for the data collection process. Surveys were designed in house by staff and were distributed electronically via email to existing customers, through the local youth athletic leagues, local home owners associations, and via social media. Response was overwhelming.

Data Summary

To recap, data was collected through the use of a simple random survey as well as through public meetings with the Recreation Advisory Commission. The survey was distributed utilizing county email, social media, handouts at special events and programs, and through mailings. The data collected included 568 responses. The data told us the following;

1. Based upon our sample size in relation to our estimated population, we have a confidence level of 95% with a confidence interval of 4%. SO WHAT DOES THIS MEAN? Most survey studies shoot for these levels and intervals on average. We are 95% confident in our answers and our margin of error is 4%. In other words, we have good, solid, representative data here.

- 2. The highest responding zip code was 23103, followed by 23063 and 23238. As one looks at the response rate by zip code, the statistical breakdown mirrors population estimates, further legitimizing how data was collected and its representation of the population.
- 3. Most respondents are between the ages of 35-46, are overwhelmingly employed, and make over \$71,000 per year as a household. Many respondents are empty nesters followed by homes with 1-4 children. The majority of homes with children in them have children between the ages of 9-12. Ages 6-8 are the second largest grouping, followed by 13-15.
- 4. True statement: Parks and Playgrounds in Goochland County are enjoyable to visit. Parks and open spaces should be important considerations on future land use decisions. A community's quality of life is enhanced through a well developed park system.
- 5. Park Visitation: Folks who are aware of and visit the parks are satisfied with all recreational locations except for the Central High School site. Awareness of facilities does seem to be an issue but this could be tied to the fact that several locations are new, naming may be an issue, and that most of the folks live a great distance from the sites. Most respondents use P & R amenities sometimes and on a regular basis.
- 6. Park Development: The following areas were identified in rank order for development.
 - 1. Eastern Goochland

Needs Assessment

- 2. Central Goochland
- Western Goochland.

Responses on this topic mirrored location origination of responses. Most folks are willing to drive 10-14 minutes to participate in activities/parks.

- 7. Amenities of Park Development: Highest Desire: Trails, Playgrounds, Picnic Areas, Multipurpose Fields, Senior Center. Lowest Desire: Field Hockey and Lacrosse Fields
- 8. Awareness: Folks receive information about their services by word of mouth, newspaper, Internet, and other publications.
- 9. Activities/Programs: Most highly desired programs and activities that aren't currently offered: Cultural arts, indoor exercise, educational enrichment, bicycling, boating/canoeing/fishing, outdoor concerts, public river access

Qualitative Data: Over 200 responses were given to our open ended questions. Reoccurring responses and feedback were as follows:

- Outdoor concerts are desired.
- 2. James River boating access is highly desired.
- 3. People tend to want access to self directed activities (indicative of busy lifestyles): walking/jogging trails, horseback riding, playgrounds.
- 4. Citizens would use parks if they were located in their areas.
- 5. Requesting alternatives to the YMCA after school program.

Needs Assessment

Facilities

In an effort to gather a representative sample of residents, all zip codes were surveyed or were attempted to be surveyed by the Parks and Recreation Department. The respondents identified walking trails, multipurpose athletic fields, playgrounds and picnic areas as the most desired new facilities. They also indicated that they believed, that overall, parks enhanced their quality of life and that all parks are enjoyable to visit.

Since the completion of the survey for facilities, construction of Leakes Mill Park, Tucker Park, as well as improvements to the Central High School site, Goochland Sports Complex, and Reynolds Recreation Complex have helped to address the combined desires of the community and the identified deficits of service standards identified in the 2010 - 2015 Master Plan.

Service Level Standards

According to survey data and the current level of service standards, Goochland currently remains in deficit in regards to adult sized baseball/softball fields, tennis courts, picnic shelters, playgrounds and soft surface trails. During the survey process, other citizen desires and deficits were noted, such as dog parks and nature trails. These deficits could potentially be met with modest funding and additional community involvement.

It should be noted that level of service standards does not address geographical facility deficits.

Many factors influence the demand for park and recreation facilities. Primary factors include the following; population size, age distribution, popularity and satisfaction of existing and desired recreational sites, facilities, and programs.

In order to assist in the planning of parks and recreation facilities, a "levels of service" standard is often employed. A level of service standards typically establish a quantity of units per population and park standards typically require an acreage requirement. This type of analysis can be determine if there are gaps in services.


In the 2010-2015 Parks and Recreation Master Plan, The National Recreation and Parks national levels of services were used. In order to more accurately depict what the levels of service are for Goochland County residents, the Virginia Outdoors Plan was utilized for the 2016-2020 Parks and Recreation Master Plan.

Identified Deficits

Utilizing the Virginia Outdoors Plan, Parks and Recreation was able to identify levels of service deficits as benchmarked against other localities in Virginia. Deficits were both mild and significant. Significant deficits included playgrounds, picnic shelters, and trails. Mild deficits were seen in outdoor basketball courts, youth soccer fields, tennis courts, bicycling, and equestrian areas.



Goochland Sports Complex

The Goochland Sports Complex, formerly known as the "Old High School" is home to several athletics based amenities. The GSC exterior facilities include a lighted multipurpose baseball/football field complete with a grass infield, scoreboards, a lighted softball field, concessions stand, as well as the County's only public skate park - Skate 522. The complex is also home to the Recreation Team. The interior of the facility includes administrative offices, a full sized gymnasium, weight room, cardio room, dance studio, and one large multi-use activity room.

Potential Upgrades/Improvements:


The Goochland Sports Complex (old high school) has seen significant improvements over the previous 5 years. Improvements to the interior of the building as well as improvements to the exterior – upgraded playing turf, new press box, improved concession building, and upgrades to the skate park.

Upgrade or Relocation – overall the Sports Complex is in good condition. However, the Fairgrounds Road project will negatively impact the lower softball field. Currently that field serves as the home and practice field for GYAA softball as well as a practice location for football. Goochland Middle School also utilizes the space.

The construction of an extension of Fairgrounds Road will eliminate the field. Relocation and/or improvements to existing playing fields could remedy the elimination of the field. Options include relocating the field to property on Bulldog Way, and/or improving the lighting at both the Sports.

Upgrades to the Sports Complex could also potentially include an upgraded concession and restroom facility and new and improved lighting.

Deficits/Needs Addressed: upgrade of heavily used facility, renovation of weight and cardio rooms, bathroom renovations, gym floor replacement

Hidden Rock Park

Hidden Rock Park is a 65 acre facility that serves various recreational interests in the Goochland community. Hidden Rock boasts 2 lighted youth baseball fields, 2 lighted softball/baseball fields, 4 batting cages, scoreboards on all fields, concession stand, 2 playgrounds, sand volleyball, basketball court, 2 picnic shelters, as well as multipurpose athletic areas. The park also includes a .65 mile nature trail.

Potential Upgrades/Improvements:

Over the previous 5 years, Hidden Rock Park has experienced some upgrades in terms of the quality of the facility. Improvements have been made to fencing and lighting. Additionally, batting cages were installed by the youth athletic league. Maintenance to the athletic playing surfaces has also increased in quality. There is a scheduled maintenance plan for the facility including seeding, fertilizing, infield amending, and safety inspections.

Despite the improvements, Hidden Rock Park does have issues that are identical to be addressed within the 2016-2020 Parks and Recreation Master Plan.

Playground – the current playground at Hidden Rock Park is aging and many of the elements within its design do not meet today's safety standards. This includes construction materials used as well as safety surfacing. For a park of Hidden Rock's size, the playground is undersized. **COMPLETE**

Drainage & Hard Surface Improvements – Hidden Rock Park, due to its design, easily floods during rains and negatively impacts maintenance efficiencies as it relates to athletic field preparation. Drainage improvements are drastically needed on all 4 baseball and softball fields. A return on investment would easily be recognized within a year or two. **COMPLETE**

Irrigation of Fields – with the recent construction of Leakes Mill Park's playing fields as well as the irrigating the Sports Complex field, Hidden Rock's fields are now second tier. Additionally, the baseball/softball fields at Hidden Rock are the most heavily used fields in the County. Irrigation would allow for a better playing surface, would stand up to the wear and tear more effectively, and would be easier to maintain.

Trail Improvements – Hidden Rock Park has a large percentage of its land that is not being utilized. Potential trail development and improvements could be undertaken to improve the parks effective use of resources. It should be noted that the majority of unused space is found within the flood plain of Courthouse Creek and is also considered wetlands.

Dog Park – One item that is often requested for development is a centralized dog park. Hidden Rock Park is deemed an appropriate location given its proximity to the Goochland County Animal Protection offices.

Deficits/Needs Addressed: trails✓, dog park✓, improving aging infrastructure, improving field conditions



Leakes Mill Park

Leakes Mill Park is a 176 acre facility located 3 miles west of Goochland Courthouse. The park features 2 fully irrigated multi-purpose athletic fields, playground and walking trails. Future development will include additional irrigated multi-purpose field space, concession stand with restrooms, additional trail heads and parking. Leakes Mill Park is home to Goochland United Soccer Association and Goochland Middle School Soccer.

Potential Upgrades/Improvements:

Leakes Mill Park opened in the fall of 2013. The park (recipient of the 2013 VRPS Best New Facility Award), addressed the major need for soccer fields for the local youth soccer organization, Goochland United Soccer Association. Phase 1 included two fully irrigated Bermuda playing fields, a playground, and trails. Phase 2 is currently under development.

Completion of Phase 2 – Leakes Mill Park phase 2 includes the design and construction of additional playing surfaces, a concession stand/restroom facility, and additional trail work. **COMPLETE**

Construction of the concession stand/restroom facility is complete. Volunteers are working on additional trails within the park. Engineering services are underway on the construction of the additional playing fields at Leakes Mill.

Phase 2 funding is currently allocated in the CIP plan until 2018.

Deficits/Needs Addressed: additional field space√, trails√, mountain bike skills course√, directional and interpretive signage



Tucker Park

Tucker Park at Maidens Crossing is a 36 acre facility located along 1,200 feet of the James River. The park is a joint venture between Goochland County and the Friends of Goochland Parks. Current park amenities include accessible parking to the river, a 1 mile walking trail, well maintained open recreation areas, the educational walk about outdoor classroom, and the "CarMax Cares" performance area.


Opened in 2012, Tucker Park's development is primarily due to the efforts of the Friends of Goochland Parks who have worked to acquire donations, grants, and in-kind donations to develop the park site. The parking lot, outdoor classroom, and CarMax Care performance area have all been developed on site. Tucker Park does require some additional work.

Upgraded Restroom – Currently port-o-johns serve the general public at Tucker Park. Due to its location within the flood plain, port-o-johns allow the flexibility to be removed. There are ways to improve the overall restroom facilities at Tucker Park while co-existing within the flood plain of the James River.

Playground – Tucker Park is the only County park without a playground. Parks and Recreation receives ample feedback from the general public regarding the need for a playground at Tucker Park. It should be noted that given the park's location in the flood plain makes it difficult to have a playground of significant size.

Additional Parking – The conceptual plan for Tucker Park notes additional parking on the western side of the park. The current parking lot allows for approximately 33 parking spaces. Additional parking could include anywhere from 150-200 parking spaces. The additional parking spaces would allow onsite parking for outdoor events, programs, and concerts as part of the CarMax Care performance area already in existence.

Deficits/Needs Addressed: restroom facilities, trails, parking for concerts and river access ✓, archery park, dog park ✓, pedestrian bridge, disc golf course.



Central High Cultural and Educational Complex

The Central Recreation Complex is a 23 acre outdoor facility comprised primarily of multipurpose athletic fields. The facility also includes two picnic areas and a quarter mile walking track. Interior amenities include a full sized gymnasium with hardwood floors as well as a multipurpose activity room adjacent to the lobby.

Potential Upgrades/Improvements:

Central High Cultural and Educational Complex has undergone a drastic transformation over the past three years. The gym facility opened in 2015 and houses a warming kitchen, and large classroom space. The Gym has received a PA system and upgraded wifi.

The front portion of the Central High Complex opened in 2018 and is home to the Cultural Arts Center, Goochland Agricultural Center, and the Artisan Center. The Cultural Arts Center features Parks and Recreation Administrative offices, a 170 seat theater, senior lounge, multiple classrooms, Central Museum, and conference room. The Agricultural Center serves as the home for Virginia Cooperative Extension and Monacan Soil and Water. It features a demonstration kitchen and a meeting space.

Currently, Parks and Recreation is working to develop the Hands-On-Dogtown Artisan Center. The first tenant, Central Virginia Blacksmith Guild, moved in to the kitchen space in December 2019.


Upgrades to Existing Lighting – The current lighting infrastructure at the Central High School complex is aging and does have limitations. Lighting upgrades would improve the lighting, cut down on utilities expense (more efficient electrical use), and would expand the playing surface to the rear of the complex.

Playground Installation – Currently there is no playground located at the Central High School complex. The service level standards currently identifies playgrounds as a significant deficit for Goochland County. Additionally, citizen feedback identified playgrounds as a strong desire for facility development.

Shelter Construction – Shelters and picnic areas intersect as a service level deficit and a stated desire for the community. The Central High School complex has plenty of space available for a shelter to be constructed.

Trail Development – A $\frac{1}{4}$ mile walking track currently exists on site. Additional acreage exists that would allow for a connecting exercise/nature trail to the northern side of the complex.

Deficits/Needs Addressed: playgrounds, shelter, trails, artisan center

Facilities in Development

East End Trails - In Development

The east end trail system is currently under development. Additional funding would assist with trail surfacing and the construction of necessary bridge crossings.

Deficits/Needs Addressed: trails, eastern recreational amenity

East End Park (Hockett Road) - Future Development

Currently the eastern end of Goochland County does not have a community park. The 2016-2020 Parks and Recreation Master Plan and service level standards identify this as a strong need. The County currently owns an 89 acre parcel of property in the eastern end. This property is located along Hockett Road approximately halfway between Route 250 and Route 6.

This County owned property has been identified not only as a potential park site but also as a potential school site. These items could co-exist on the same property.

The Hockett Road site park development could include a wide variety of recreational amenities, yet to be determined.

Deficits/Needs Addressed: eastern park, trails, playground, shelter, TBD.

Matthews Park - COMPLETE

Matthews Park is currently under development. The initial phase includes a parking lot, playground, picnic shelter, and trails. This phase of development is scheduled for completion by Spring of 2016.

Upgraded Restroom – current conditions at the park site call for the use of port-o-johns for restrooms. It is recommended that a more permanent structure be put in place for public restroom facilities.

Deficits/Needs Addressed: western park, trails, shelter, playground

In addition to surveying community residents and users of Department resources, Recreation Team members also work to analyze other organization's efforts in the community to provide services. Additionally, through these efforts, Recreation team members work to streamline existing programming efforts; tying them directly to the survey feedback and matching the feedback to the efficient use of existing and future County resources. This streamlining is accomplished through the use of the Department's "programming matrix" and its EAM policy.

The 2016-2020 Parks and Recreation Master Plan ultimately establishes recommendations on future park and programming development. As mentioned, the following criteria is utilized for the recommendation process.



Recommendations

Align with the County's Strategic Plan.

It has always been the goal of the Department to minimize impacts to the Department's overall operating budget. This can be accomplished in a myriad of ways. For example, parks and outdoor space can be configured in a way that only minimally increases grassy surfaces so as not to significantly increase mowing and maintenance costs (see Matthews Park.)

Many of the recommendations seek to make improvements to existing facilities, thus minimizing the impact to the operating budget. All recommendations seek to enhance the quality of life of Goochland citizens.

Facility and programming development would seek to meet the needs/desires of the public.

All recommendations are validated through our qualitative and quantitative data analysis.

Facility development would seek to meet the deficits identified by the levels of service standards.

All recommendations looked for an intersection of data analysis and level of service standard deficit. Where these lines of intersection occurred, recommendations were made

Complete existing projects/facilities as a priority.

Leakes Mill Park is an example of this. In other words, we should finish what we start.

Improve high volume use areas.

Park and recreation spaces that see a high volume of use such as Hidden Rock Park and the Sports Complex are going to need improvements made to their existing infrastructure. Irrigation and improved turf areas are needed to keep up with the extensive and exhaustive use of the facility.

Listed below are the recommendations for the 2016-2020 Master Plan, as well as cost estimates for development.

Programming

Throughout the year Parks, Recreation and Facilities staff circulate surveys to gain citizen input on programmatic offerings. Over the past few survey cycles several trends have emerged. The majority of the respondents were from the 23063 zip code. They primarily identified ages 0-10 and 18-55 as the ranges in need of additional programming. Also identified was youth athletics and educational programming, along with adult cooking, group exercise classes, and 'how to'/'do it yourself' classes as areas of interest. In addition, these respondents repeatedly have requested additional family activities, programming in the east, afterschool programs, tennis programs, Homeschool classes, and classes to be offered at Byrd Elementary School.

Programming Recommendations

- 1. Continue to evaluate existing offerings through the programming matrix.
- 2. Offer in house adult sports such as basketball and flag football.
- 3. Work with additional non-profits to create expanded adult softball program.
- 4. Continue to cultivate Tucker Park's use and nature/educational based programming.
- 5. Continue to offer self directed activities ex. Weight and cardio rooms, open gym sports for all ages, clubs, and senior activities.
- 6. Focus on facility use and rentals for community activities.
- 7. Continue to utilize non Parks and Recreation facilities for programming in Eastern and Western Goochland.



Recommendations

Operational Impacts

Facilities development and programming efforts, however minimal, will impact operational budgets. Examples include:

- 1. Maintenance Team will require additional staff for changes in mowing frequencies and trail maintenance and capital expenses.
- 2. Recreation Team will need additional full time and part time staff to keep up with facility use and demand of services.
- 3. Maintenance of upgraded playing surfaces will require additional expenditures related to nutrient management program.
- 4. More frequent mowings will need to take place on upgraded fields.
- 5. General maintenance expenditures will increase due to additional facilities.

As facilities are improved or developed, additional analysis will be needed to specifically identify their operational impacts.

Basic Assumptions

Operating Impact - Based upon current minimum maintenance standards and a three year trend analysis of existing operating hands specific to recreation expenditures we can identify some basic assumptions:

Irrigating Fields - An additional .75 acre field will require an additional 36 hours per year or an extra \$3,000 in operating impact.

Trails - Impacts include staff time for inspections and

general maintenance ~\$1,500 per year per mile for trails.

Playgrounds - Impacts include staff time for inspections and general maintenance ~\$300 per year per playground.

General Maintenance/New Facility - \$6,000 per 50 acres based upon a prorated acreage expenditure related to current facilities and tracked expenses. *Includes staff and equipment costs.

Shelter - \$250 per year impact.

Funding Sources

Funding parks and recreation (CIP) improvements and facility development requires a strategy that would identify multiple methods for one time funding sources. It is important to note that the County does not have to fully fund all improvements. Previous efforts for funding include soliciting grants, utilizing volunteers, community organizations, and donors for either creating or improving existing facilities. Examples of these can be found at every park and recreation location in Goochland County.

Listed below are examples of potential funding sources:

Goochland County Capital Improvement Plan – several projects have been funded through the County's CIP program. Facilities include Leakes Mill Park, Matthews Park, and the East End Trails.

Recommendations

Grant Funds – Tucker Park utilized Dominion Resources and CarMax Cares grant funding to make enhancements and additions to the park. Leakes Mill Park utilized Recreational Access Funds.

In-Kind Contributions – Hidden Rock Park and the Sports Complex have both seen improvements through the use of in kind donations. Tucker Park exists today solely through the in-kind contributions of local businesses to construct the parking lot.

Naming Rights – The football field at the Sports Complex utilized naming rights as a way to install much needed irrigation on the field.

Advertising and Sponsorship – Field advertising does generate revenues that can be used for onetime expenses.

Easements – Easements can be utilized for recreational amenities. The East End Trail development is one large

recreational easement.

Adaptive Reuses – The Central High School complex is an example of adaptive reuse.

It is important to keep in mind all of these potential sources for park and recreation facility development and improvement. Creativity, patience, and cooperation will be required to implement a sound and diverse funding strategy.

The following programming recommendations have been identified for 2020-2023.

- ✓ Continue to evaluate existing offerings through the programming matrix.
- ✓ Offer in house adult sports such as basketball and flag football.
- ✓ Work with additional non-profits to create expanded adult softball program.

- ✓ Continue to offer self directed activities ex. Weight/cardio rooms, open gym sports, clubs, and senior activities.
- ✓ Focus on facility use and rentals for community activities.
- ✓ Continue to utilize non Parks and Recreation facilities for programming in Eastern and Western Goochland.

2020-2023 Programming Recommendations

- 1. Continue to grow Senior offerings including trips, workshops, luncheons, and other social opportunities.
- 2. Increase presence in Eastern Goochland through utilization of non Parks and Recreation facilities.
- 3. Work with Agricultural Center to offer educational programs.
- 4. Continue to work with local non-profit to offer Theatre performances.

- Project Description: This project proposes the design and construction of a new eastern park. The need for an East End Park was identified in Sports Complex Field Relocation—District the 2016-2020 Parks and Recreation Master Plan.
- Location/Site Status: TBD

East End Community Park

- Project Description: This project proposes a community park to be established in the eastern portion of Goochland to provide community based recreation access.
- Location: TBD

Tucker Park—Regional

- Project Description: The Tucker Park board walk project would involve connecting the western side of Tucker Park with the eastern side.
- Location/Site Status: Tucker Park at Maidens Crossing – 1300 Maidens Road

Hidden Rock Park—Regional

 Project Description: Hidden Rock Park upgrades would include the installation of irrigation on all lighting improvements, plaving surfaces. scoreboard replacement. and drainage improvements to the existing fields. Irrigation and field upgrades would need to be performed in the fall with seeding occurring in late Spring. Hidden Rock Park is the most highly used park facility in Goochland County. The playing surfaces experience high traffic volumes necessitating an improvement. Additionally. infrastructure is nearing 15 years of age, requiring attention.

Location/Site Status: 1920 Hidden Rock Lane, Maidens, VA

- · Project Description: This project is proposed to address an impact created by the Fairground Road Extension & Intersection Improvements project (FY 2018). Completion of that project will eliminate a lighted playing and practice space for baseball, softball, and football teams at the Goochland Sports Complex. As a result, this project proposes improvements to the athletic fields at the Central Recreation Complex (Central High School) to relocate athletic leagues usage. Improvements would include updated improved lighting systems & upgraded and irrigated playing surfaces. This project is contingent upon the Fairground Road project moving forward.
- Location/Site Status: Recreation Central Complex - 2748 Dogtown Road.

Leakes Mill Park—District

 Project Description: Phase I of Leakes Mill Park was completed in FY 2013. The initial recreational complex consists of a parking lot and two multipurpose fields that have begun to meet the needs of both the soccer community and outdoor athletic/recreational needs of the County. Phase II expands the complex and incorporates a

concession and restroom building, additional parking spaces, and one oversized playing space that can be subdivided into smaller fields. Completion of this project alleviates the demand on other Parks & Recreation facilities and provides new opportunities for expanded programmatic offerings and local tournaments. In addition, walking/jogging trails and a playground Matthews Park Improvement—District have been completed. Other amenities may be added depending on demand and available resources.

Location/Site Status: 3951 River Road West (west of the Courthouse Village)

East End Trails - Regional

• Project Description: This project proposes to utilize existing water and sewer easements in the West Creek Business Park. The trail is approximately 4 miles in length with varying legs and includes the capability to access the Tuckahoe Court House Greenway Project - District Creek.

Elk Island Recreation Area—Community

· Project Description: This project proposes the development of a passive recreation area located along the James River in the far western end of the County. Development would include picnic areas, a short trail, and a potential non-motorized boat ramp.

Oilville Area Park—District

•Project Description: This project proposes the acquisition of property, design, and construction of a facility located within the Oilville/Cardwell Road Corridor. The project would seek to alleviate existing overcrowding of athletic fields at Hidden Rock Park

as well as to provide additional amenities access to the eastern Goochland residents. Trails. playgrounds, and athletic fields continue to be in demand by residents as well as in deficit to County's adopted service level deficit.

•Location: TBD

•Project Description: This project proposes the improvement of amenities at Matthews Park to include additional parking, playground expansion, trail improvements, and potential open recreation areas. This project would seek to alleviate continued deficits in parks and recreation services identified within the Park and Recreation Master Plan as well as to meet service level demands for the western end of the County.

Location: Matthews Park

•Project Description: This project proposes interconnecting multiple recreation facilities within the Court House area. The Greenway would seek to connect Hidden Rock Park, J Sergeant Reynolds, The Goochland YMCA, The Court House Trails, Court House Complex, and Tucker Park. Greenway would utilize existing park land, water/ sewer easements, and sidewalks.

Location: Court House Village.







Q3 What is your current employment status?



Q4 What is your average household income?



Q5 How many children are in your household?



Q6 How many active adults/seniors are in your household?



Q7 Please identify your child(ren)'s age range.










